- **Initiators group:** the founding members of the initiative: UNESCO, the French Ministry of Higher Education and Research, Université de Lorraine, Inria, SPARC Europe, Charité and PLOS - monitors progress
- **Coordination Committee:** Arianna Becerril García (REDALYC/AmeliCA), Laetitia Bracco (Université de Lorraine), Andrea Davidson & Vanessa Proudman (SPARC Europe), Ana Persic & Rania Sabo (UNESCO) - oversees overall day-to-day OSMI operations
- **Governance** to be discussed this year.
A diverse and inclusive governance structure is paramount

Who we are: Participants

- 68 confirmed members as of 3 March 2025
- Africa: 10 / Asia: 9 / Central/South America: 4 / Europe: 40 / North America: 4 / Oceania: 1 → we should all make sure all regions are heard!
- Affiliations: 30 at university and/or research institution; but also representation from libraries, data service providers, research infras, publishers, national OS policymakers, funders, private sector, IGOs, and NGOs
- Stakeholder groups: 19 institutions interested in serving OSMI, 16 OS policy makers, 12 content provider; Out of remaining 19, 14 are researchers
- Of course many of us have multiple roles!

Working group 1 Key tasks



Deliverable: A needs analysis report by the end of 2025.

The working group will:

- Map the key stakeholders and beneficiaries to better understand who is impacted by OS and how, and who benefits from it at the international, national, and local levels.
- Explore the scope of OS monitoring and define what should be monitored and why.
- Identify areas that require quantitative and/or qualitative methods to serve the needs of OS monitoring effectively.

Role of the chairs

Launch of the chairs' election

- The working group members will be invited to vote online for two chairs between March 19th and March 30th
